

INVITATION TO BID

NOTICE IS HEREBY GIVEN, that the Board of Commissioners, Palm Beach County, State of Florida, will receive sealed bids from qualified Contractors, at:

until the hour of **2:00 PM**, Local Time, **June 21, 2016** and said bids will be opened and publicly read immediately thereafter in the conference room, at the above address, on the same day for:

The work generally consists of:

The mill and overlay at variable depths of the existing Hot Mix Asphalt (HMA or asphalt) pavement and shoulders, the removal of existing shoulder pavement for replacement with new full strength pavement to accommodate the widening of the fillets at the taxiway connectors and widening of the existing shoulders at various locations to meet current FAA standards. This work will also require modifications to the existing lighting, signage and pavement markings, as well as grading within the Taxiway Safety Area to ensure compliance with FAA criteria.

The work must conform to plans and specifications, which may be obtained or examined on or after **May 23, 2016**. The Department of Airports is not responsible for the content of bid documents obtained by means other than indicated below:

The plans can be printed at full size (22" by 34"). The Contractor should access the site on a daily basis to be aware of any new data that is added to the site. The potential bidder shall not, for any reason, provide the access data to any other person or entity.

Bid proposals must be submitted on the forms provided by Palm Beach County and accompanied by a bid security in the form of a certified check, cashier's check, money order or a bid bond submitted on the form provided, in favor of Palm Beach County in the amount of not less than five percent (5%) of the bid price.

All bids must be submitted in a sealed envelope as described in the INSTRUCTIONS TO BIDDERS.
