The work generally consists of:

The rehabilitation of the general aviation Runway 10R-28L and the construction of a new taxiway connector located in the southwest portion of the Palm Beach International Airport property. Runway 10R-28L, southern parallel to Runway 10L-28R, is 3213 feet long and 75 feet wide and is constructed of Hot Mix Asphalt (HMA), the new taxiway connector will connect Runway 10R-28L to the south parallel taxiway to Runway 10R-28L and will require the demolition of an existing taxiway connector. The Project includes the construction of new bituminous taxiway pavement and shoulders, variable depth mill/overlay of the runway pavement and interconnecting taxiways within the Runway Object Free Area (OFA), full depth asphalt pavement removal, drainage modifications, electrical lighting and signage modifications and pavement markings.

The work must conform to plans and specifications, which may be obtained or examined on or after **June 27, 2016**. The Department of Airports is not responsible for the content of bid documents obtained by means other than indicated below:

Bid proposals must be submitted on the forms provided by Palm Beach County and accompanied by a bid security in the form of a certified check, cashier's check, money order or a bid bond submitted on the form provided, in favor of Palm Beach County in the amount of not less than five percent (5%) of the bid price.

All bids must be submitted in a sealed envelope as described in the INSTRUCTIONS TO BIDDERS.
